

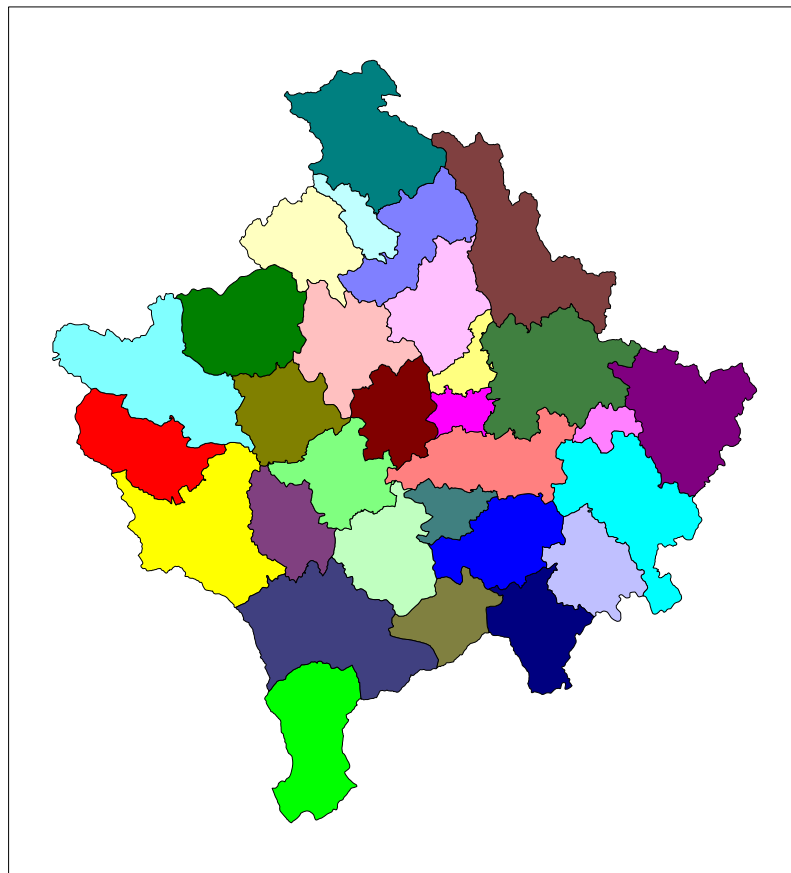

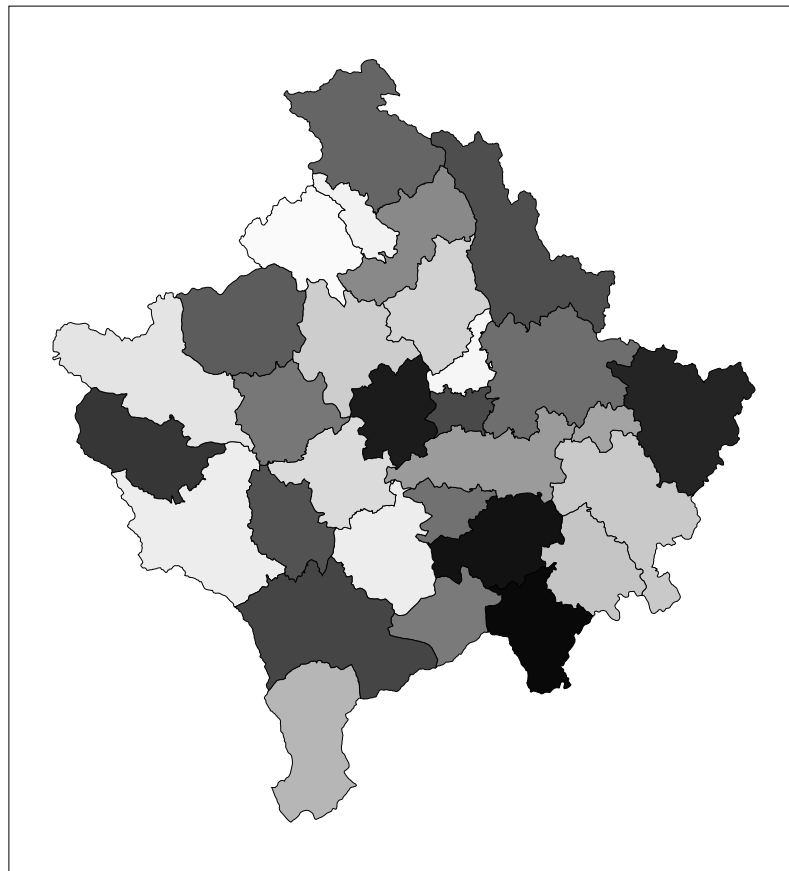

Sector of jurisprudence statistics has made efforts to provide information in this area with the aim to offer users a comprehensive statistical data.

Statistical publication of the jurisprudence statistics sector, the sixth in a row, contains data for 2008 for these indicators:

- a)** Adult persons indicted of criminal offenses (Municipal and District Courts),
- b)** Adult persons convicted of criminal offenses (Municipal and District Courts).

The data are related to adult perpetrators of criminal offences according to gender, nationality, submitter of prosecution proposal, proceeding of the case and the type of conviction or sentence.

All published data are given under the relevant chapter and article of criminal case. Data are published on the country level.

Interested for specific criminal acts of Municipal and District courts can be directed in the Jurisprudence Statistics Sector at the SOK.

Figure 1. Proceeding of the case in municipal courts, expressed in %

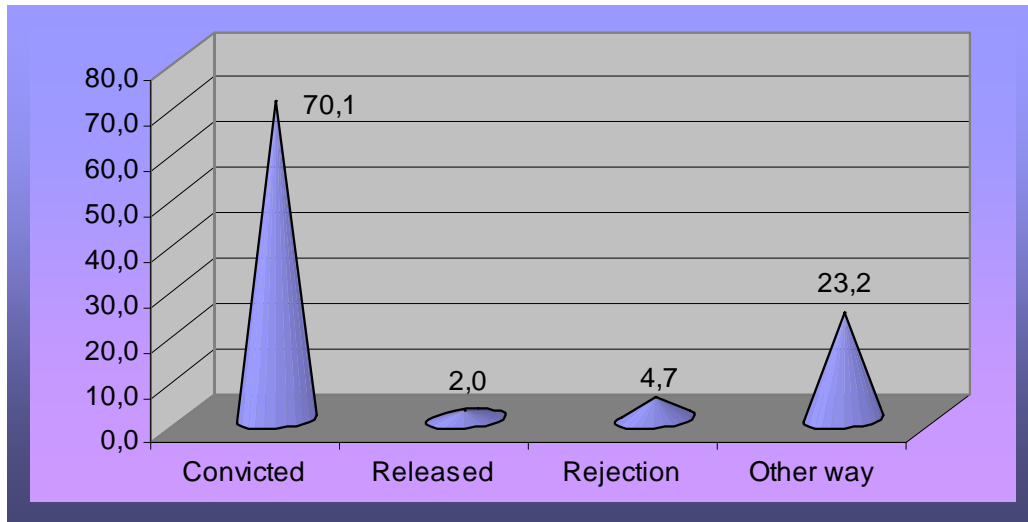


Figure 1.1: Proceeding of the case in district courts, expressed in %

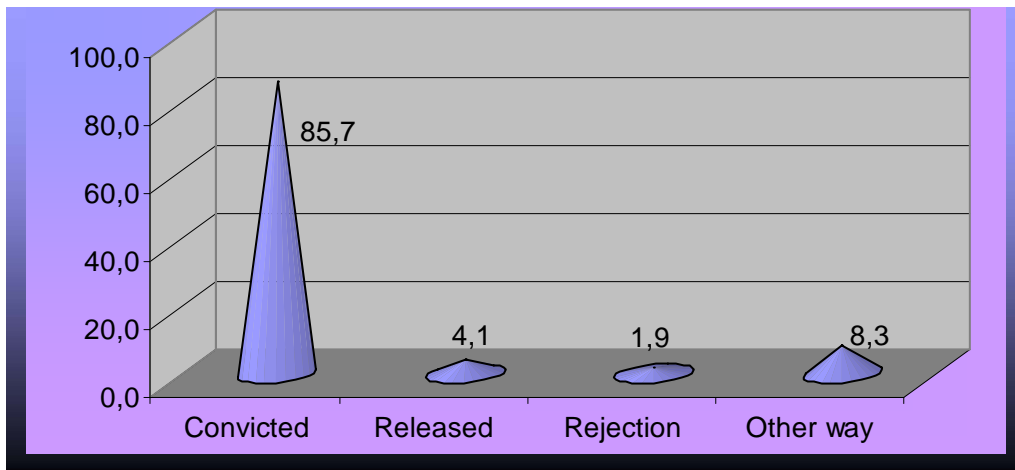

Figure 2: Indicted in municipal courts according to the motion for prosecution and gender, expressed in%

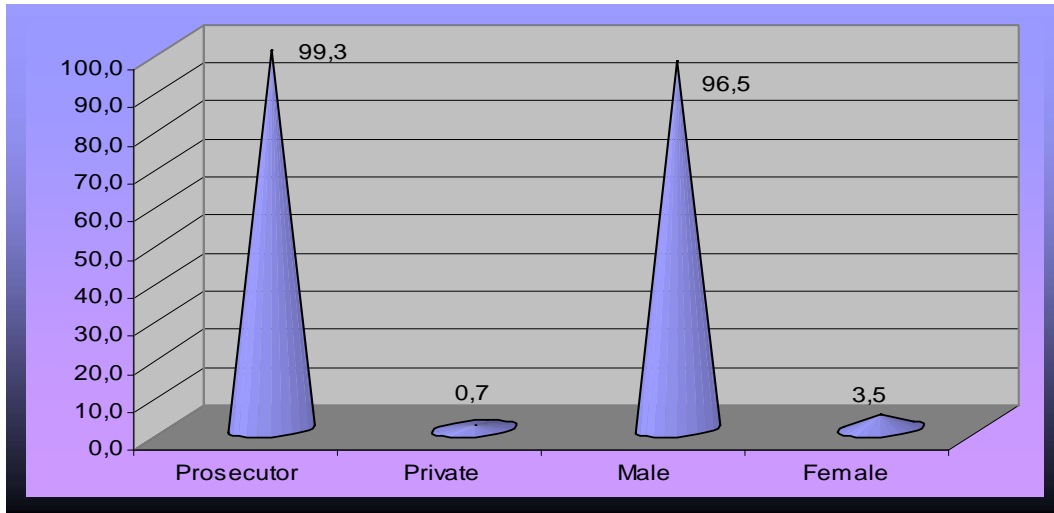


Figure 2.1: Indicted in the district courts according to the motion for prosecution and gender, expressed in%

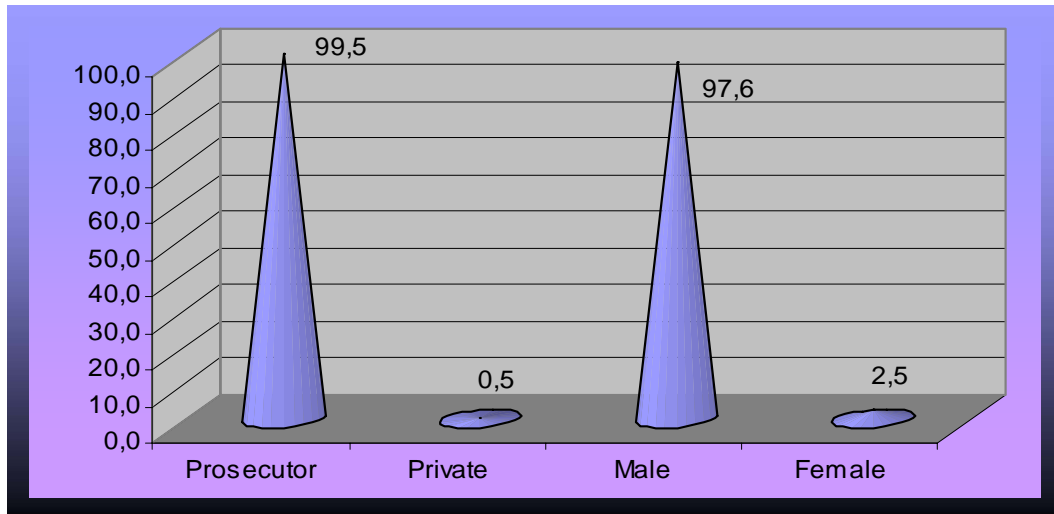

Figure 3: Indicted in municipal courts by nationality, expressed in%

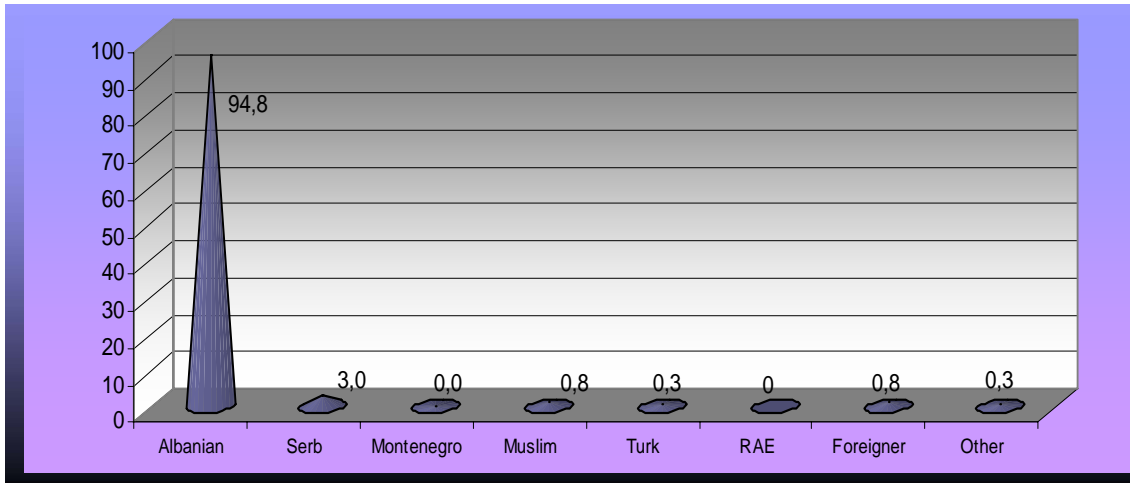
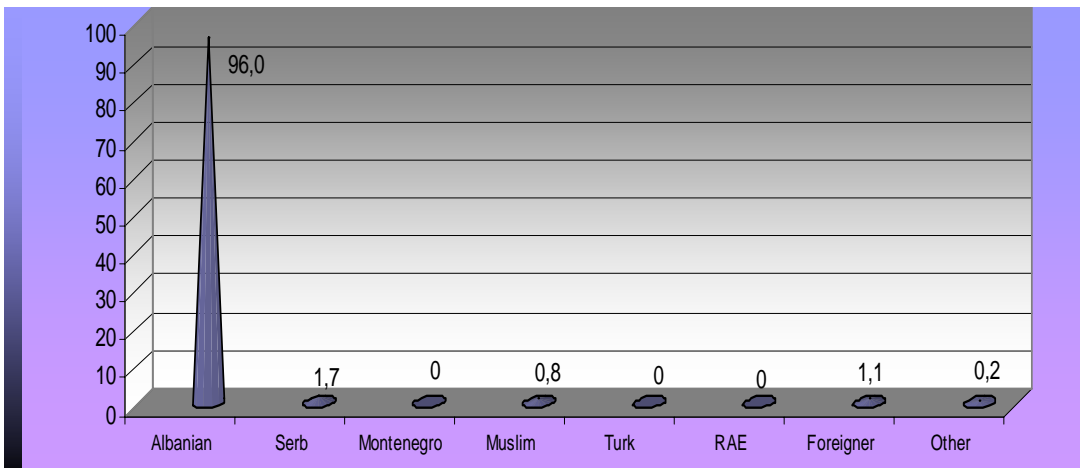


Figure 3.1: Indicted in the district courts according to nationality, expressed in%

Figure 4: Number of adult persons convicted according to municipal courts in 2003 / 2008

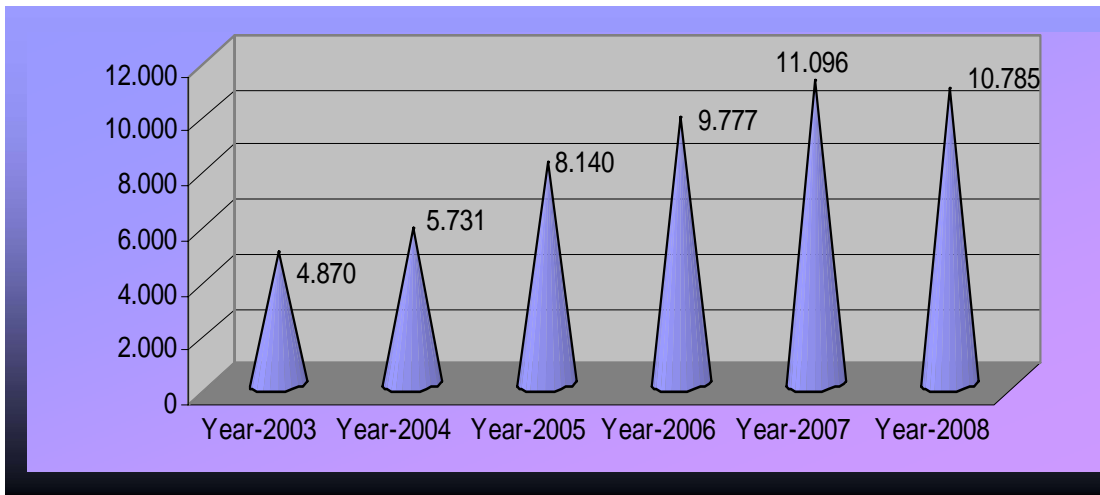


Figure 4.1: Number of adult persons convicted according to district courts in 2003 / 2008

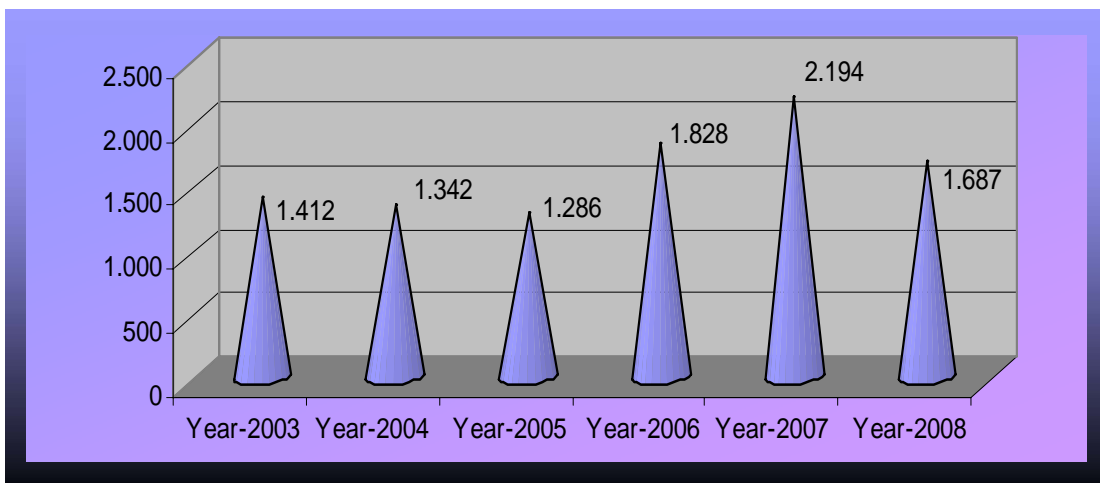

Figure 5: Convicted persons according to gender in municipal courts, expressed in %

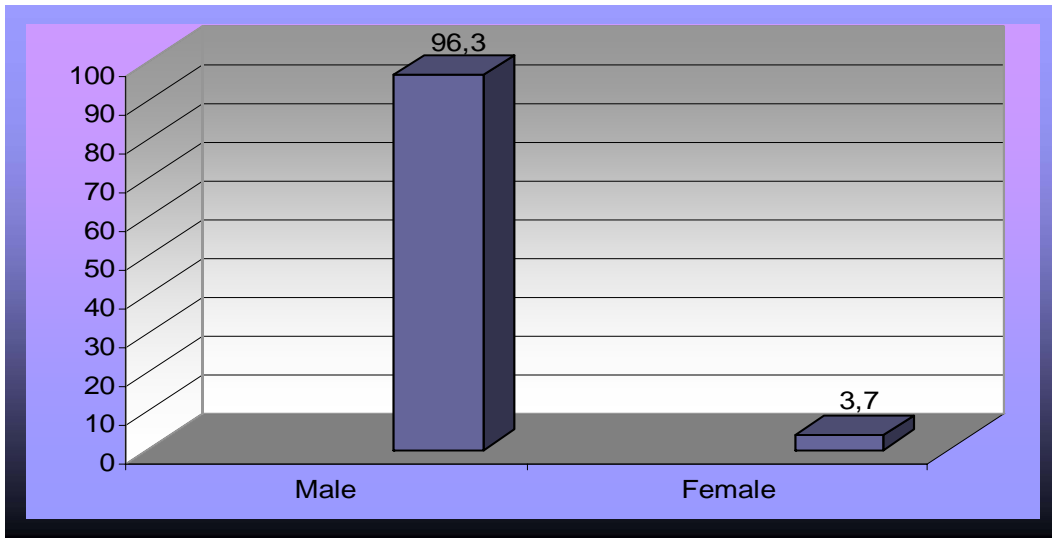


Figure 5.1: Convicted persons according to gender in district courts, expressed in %

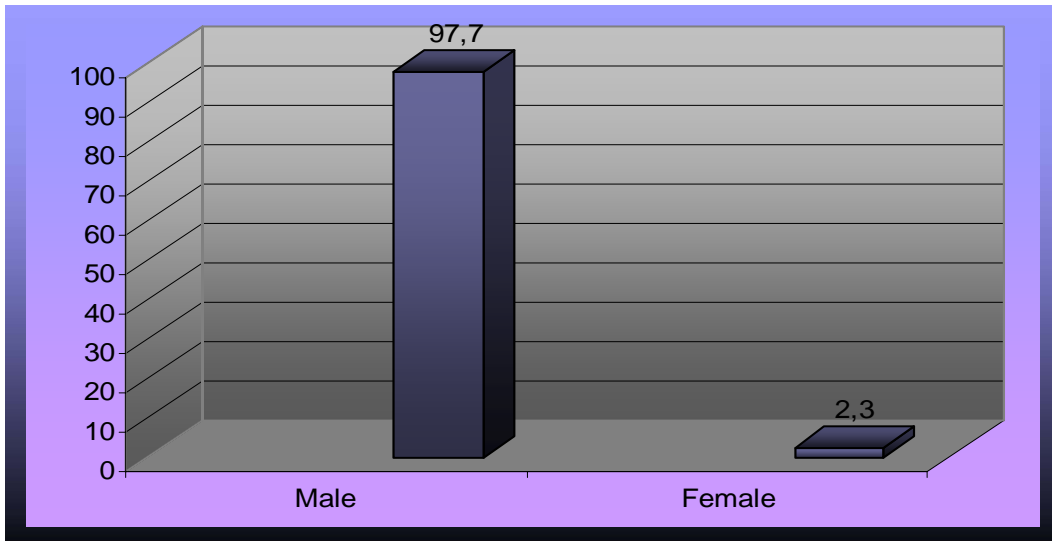

Figure 6: Convicted persons according to nationality in municipal courts, expressed in %

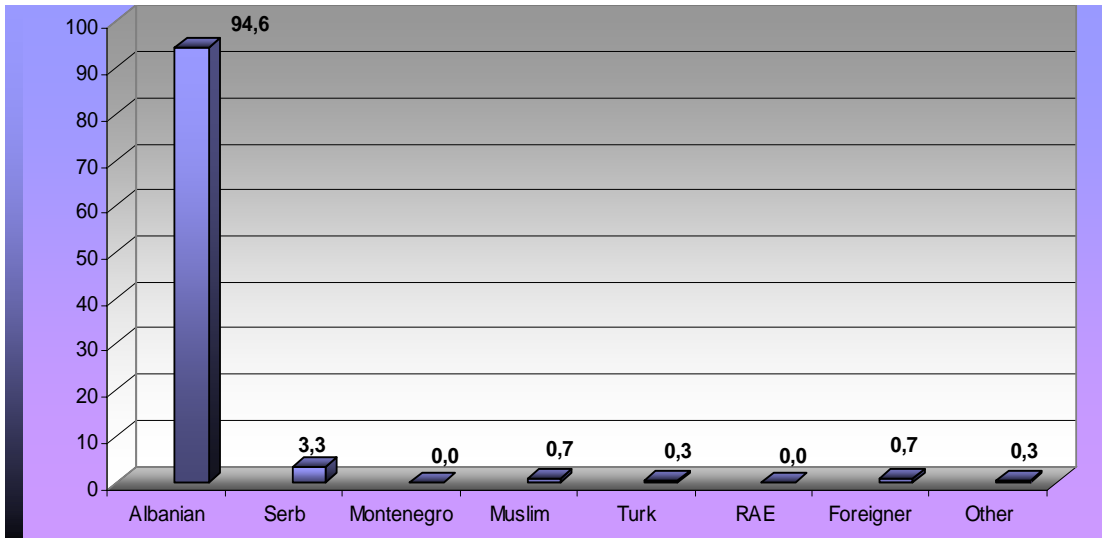


Figure 6.1: Convicted persons according to nationality in district courts, expressed in %

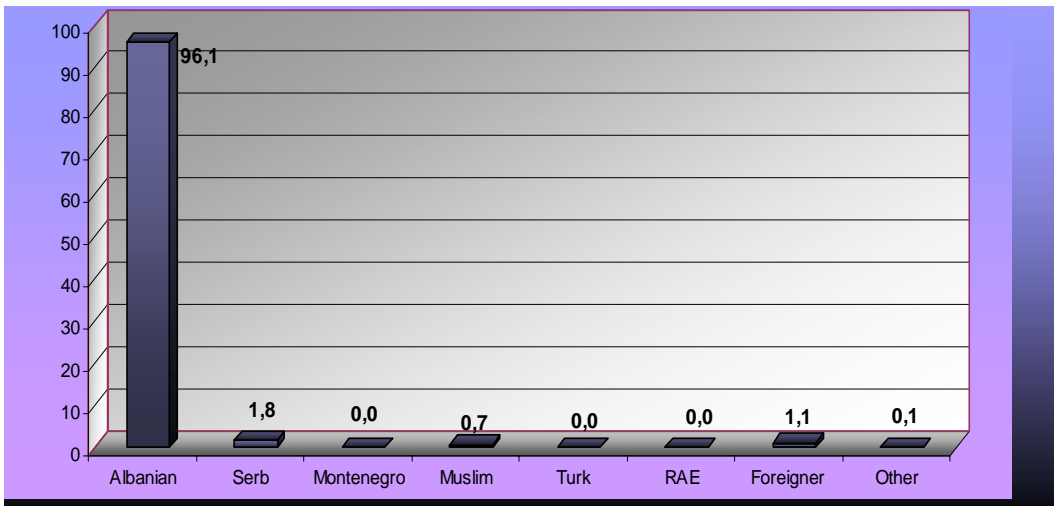

Explanations for users

Justice System

According to the level of organization of courts, judicial power is exercised by:

- Municipal courts,
- District courts,
- Supreme Court,
- District Commercial courts,
- Municipal Courts for Minor Offences, and
- Higher Court for Minor Offences.

Courts are bodies of state power.

In the performance of judicial power, they decide on disputes over basic personal relations, rights and obligations of citizens, pronounce convictions and other measures to perpetrators of criminal offences and other offences punishable by law in force. Also decide on the legality of various acts of state bodies, resolve or settle disputes about property and labor relations, and other relations as set forth by law.

Observed units

Observed units are perpetrators of criminal acts.

The notion of a criminal offense perpetrator means adult and juvenile perpetrator of criminal offences or acts whether as perpetrator, co-perpetrator, incentive or assistance in such an act.

Adult perpetrator of criminal offence is considered adult person who at the time of committing the criminal offence was or is 18 years old.

Juvenile perpetrator of criminal offence is the person who at the time of committing the criminal act was or is 14 years old, but has not reached 18 years of age.

Juvenile perpetrators of criminal offence are divided into:

- a) Young juvenile, and
- b) Adult juvenile.

The young are juvenile perpetrators of criminal offences that belong to the age groups 14-16. To this category may be pronounced only educational measures.

The juvenile adults are persons belonging to age group of 16-18 years.

Basically, even to this category is pronounced educational measures but in certain cases the law may pronounce measures of the juvenile prison sentence.

Classification of crimes

Classification of crimes (offenses) according to their nature is always referring to criminal law (Penal Code) in force.

The notion of criminal offence ^a

A criminal offence is an unlawful act which is defined by law as a criminal offence, the characteristics of which are defined by law and for which a criminal sanction or a measure of mandatory treatment is prescribed by the law.

a. The notion of a criminal offence is taken by Article 6 of the Criminal Code of Kosovo.

Statistical Office of Kosovo, a brief description

The Statistical Office of Kosovo (SOK) is a professional office operating since 1948. The SOK passed through some of the historic phases and was structured by the state rule of that time. SOK restarted its work on August 2, 1999, as an independent and professional office working in the frames of the Ministry of Public Administration (MPA). SOK is financed by the Kosovo Consolidated Budget and by donors for the various projects.

The Statistical Office of Kosovo acts pursuant the UNMIK Regulation 2001/14 that entered into force on July 2, 2001. A medium-term Master Plan is being developed for the statistical system of Kosovo compatible with the European Statistics.

The SOK Organization Structure; composes of four departments for production of statistics (Department of Economic Statistics and National Accounts, Department of Population Statistics, Department of Social Statistics and Department of Agricultural and Environment Statistics), seven Regional Offices (located in Gjakova, Gjilan, Mitrovica, Peja, Prizren, Pristina and Ferizaj), two support departments (Department of Methodology and Information Technology, and Department of Administration), as well as the Office of the Population Census.

Total number employees is 134, of them 96 (71.6%) within the SOK offices whilst 38 (28.4%) in regional offices.

There is also a support and cooperation with the international institutions.

The Statistical Office of Kosovo covers Kosovo entirely. For implementation of the surveys in the field, the SOK uses appropriate sampling and methodology approach. In the collection of the reports from the reporting units, the SOK engages professionals, technicians, administrators and civilians from the local offices and regional field population census.

Recently, a team of national and international experts is working in the project of the population census.

SOK Mission is to fulfill the needs of the users with the reliable statistical data and with regular analyses in order to support and provide government departments with the proper information for decision-making process including other users as well.
