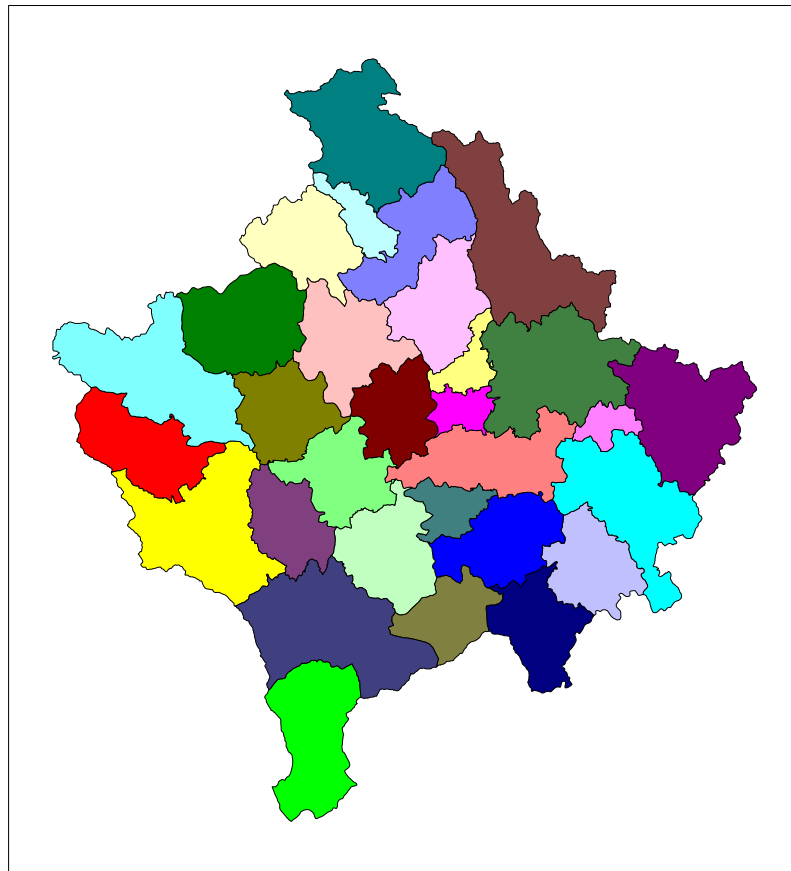

Introduction

Jurisprudence Statistics Sector has made efforts to ensure the data collection on this area with intention to make comprehensive statistics available to users. This is the third statistical publication of Jurisprudence Statistics Sector and contains data for 2005 for the following indicators:

- a. Criminal cases proceeded by (Municipal Courts and District Courts)
- b. Persons indicted of criminal offences (Municipal Courts and District Courts)
- c. Persons punished of criminal offences (Municipal Courts and District Courts)
- d. Persons punished of minor offences (Municipal Courts)

The statistics are related to the perpetrators by the age group (***Adults and Juveniles***), ***sex, ethnicity, type of punishment, motion for prosecution, type of proceedings of cases and indictments, duration of procedure as well as the action carried out during the commission of the criminal offences and the number of co-perpetrators participating in the criminal offences.***

All statistics published are given according to the respective chapter of the criminal offences and articles, and have been collected in Kosovo wide.

Data source for Statistics on Jurisprudence is the Department of Judicial Administration (DJA). The Statistical Office of Kosovo is grateful to the Department of Judicial Administration and especially to Statistical Office within the Department of Judicial Administration for cooperation and provision of data collected from courts.

People being interested in statistics according to concrete criminal offences by Municipal Courts and District Courts may approach the Jurisprudence Statistics Sector within this Office.

The number of persons punished in Municipal Courts in 2005 compared to 2004 has been increased by 2.409 punished persons of adult age, whereas the number of adults punished in District Courts was decreased by 56 persons.

Chart 1: Number of adults punished in Municipal Courts according to 2003 /2005

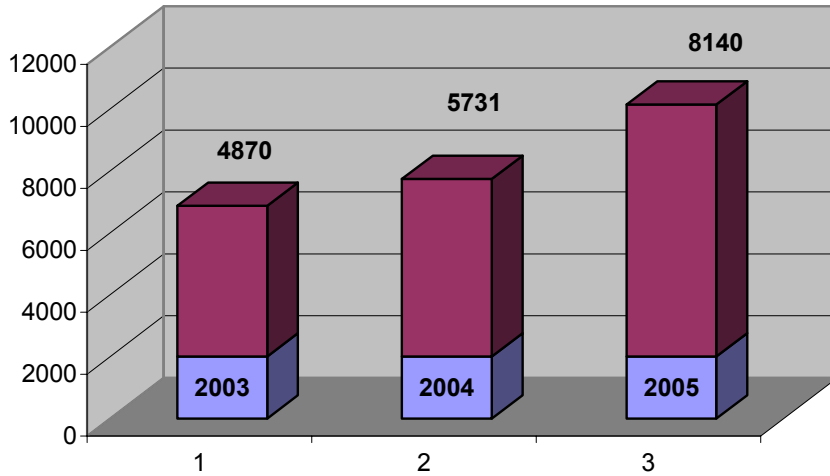


Chart 1.1: Number of adults punished in District Courts according to 2003 /2005

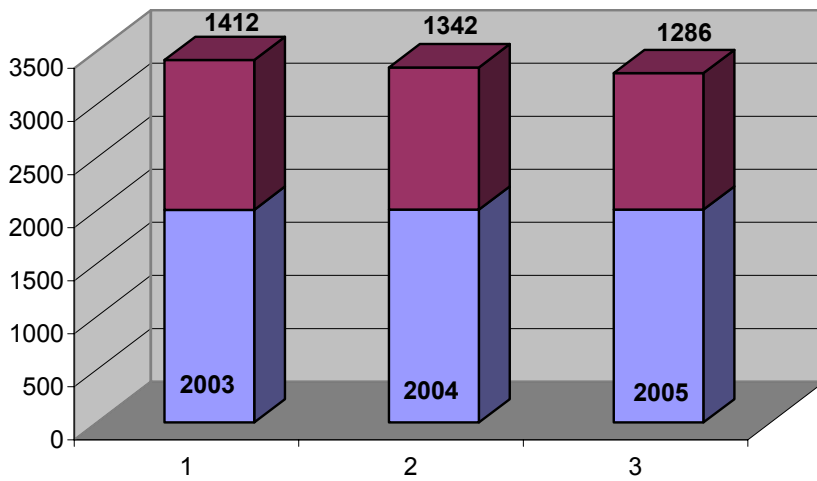

Total number of cases in Municipal Courts was 9.295, and for 3.293 or 35,4% the procedure lasted from one to three years, whereas for 1.474 cases or 15,9 % the procedure has been extended for more than three years. Out of 1.261 cases proceeded by District Courts, the procedure for 399 cases or 31,6 % the procedure lasted from one to three years, whereas for 62 cases the procedure has extended for more than 3 years.

Chart 2: Duration of procedure in case proceedings in Municipal Courts presented by %

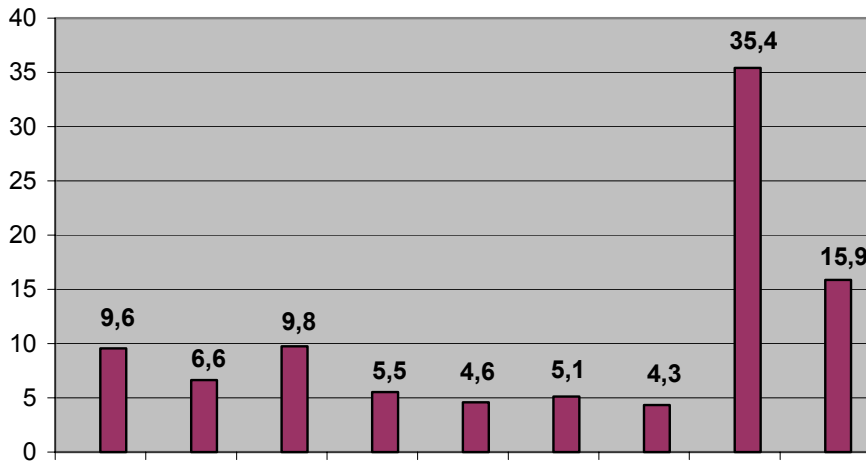


Chart 3: Duration of procedure in case proceedings in District Courts presented by %

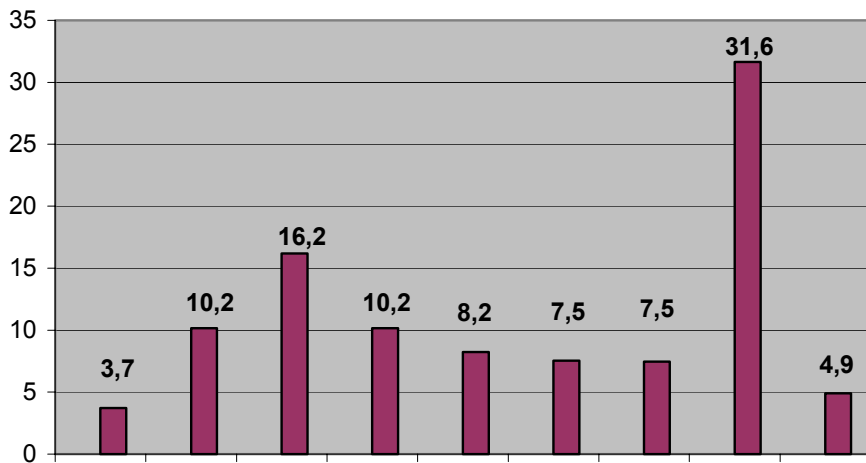

Out of 9.295 cases proceeded in Municipal Courts, 7.094 or 76,3 % have been resolved by conviction decisions pronounced, whereas out of 1.261 cases proceeded in District Courts, 1.060 or 84,1 % of cases have been resolved by conviction decisions pronounced.

Chart 4: Type of case proceedings in Municipal Courts by %

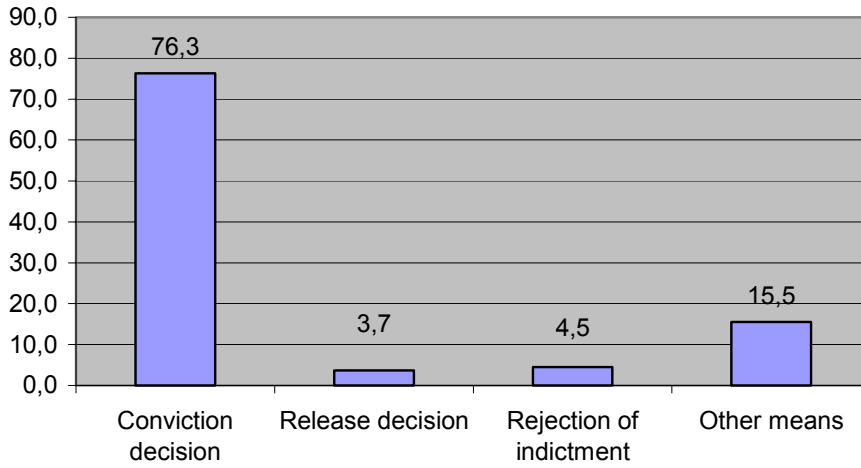


Chart 5: Type of case proceedings in District Courts by %

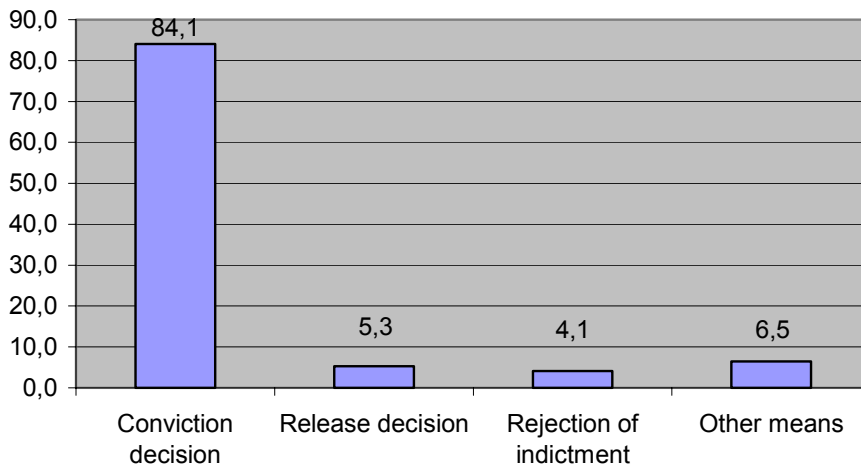

Out of 10781 defendants in Municipal Courts, 10.285 or 95,4 % were of male sex, whereas there were 496 or 4,6% female defendants. Out of 1.612 defendants in District Courts, 1.505 or 93,4 % were of male sex, whereas there were 107 or 6,6% female defendants.

Chart 6: Defendants in Municipal Courts by motion for prosecution and sex presented by %

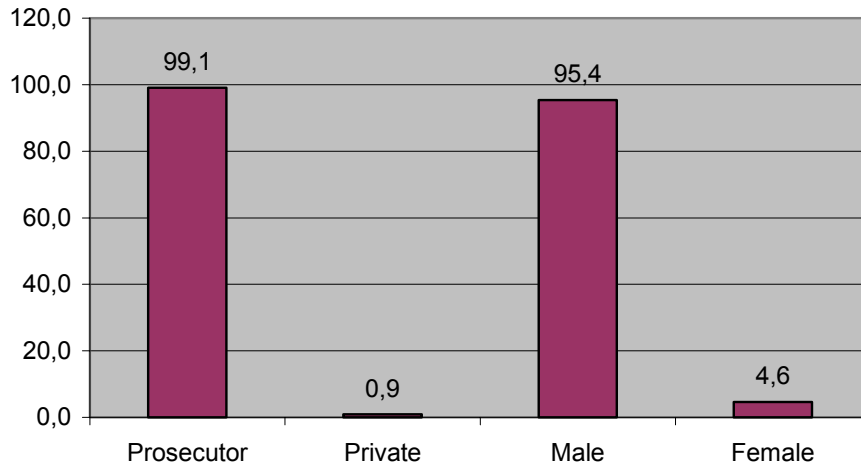


Chart 7: Defendants in District Courts by motion for prosecution and sex presented by %

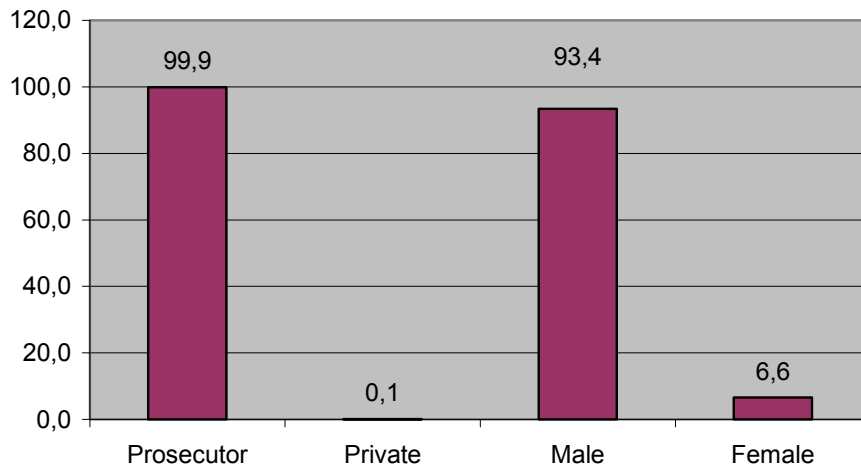

Chart 8: Defendants in Municipal Courts by ethnicity presented by %

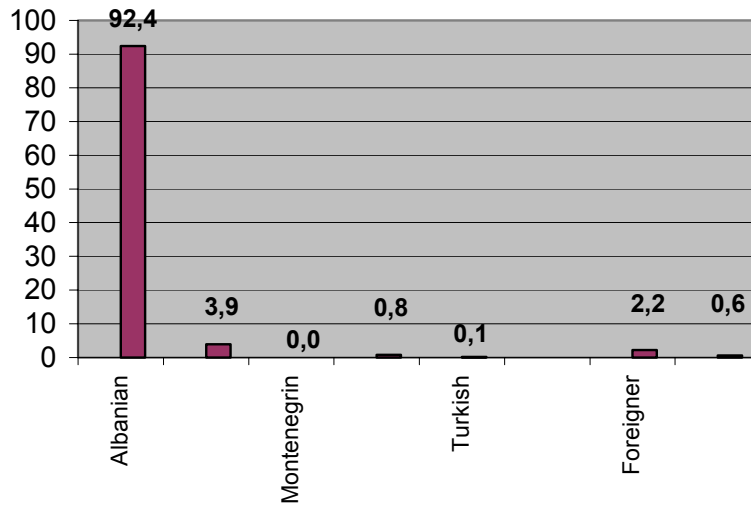


Chart 9: Defendants in Municipal Courts by ethnicity presented by %

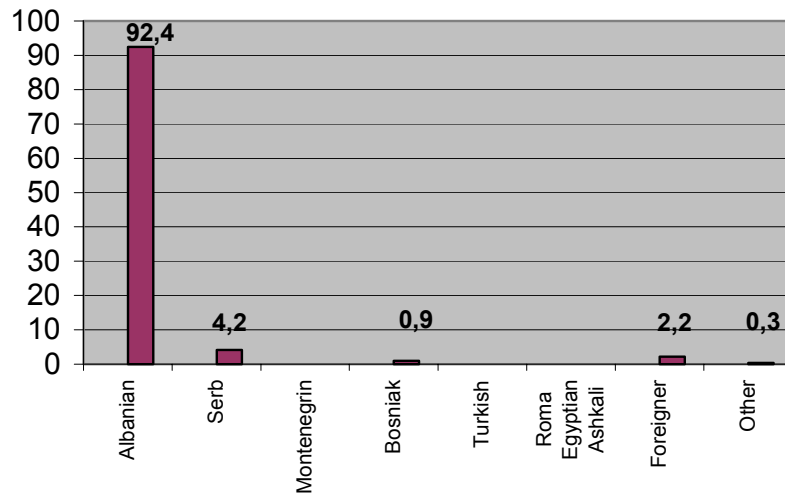

Chart 10: Type of indictment proceedings in Municipal Courts by %

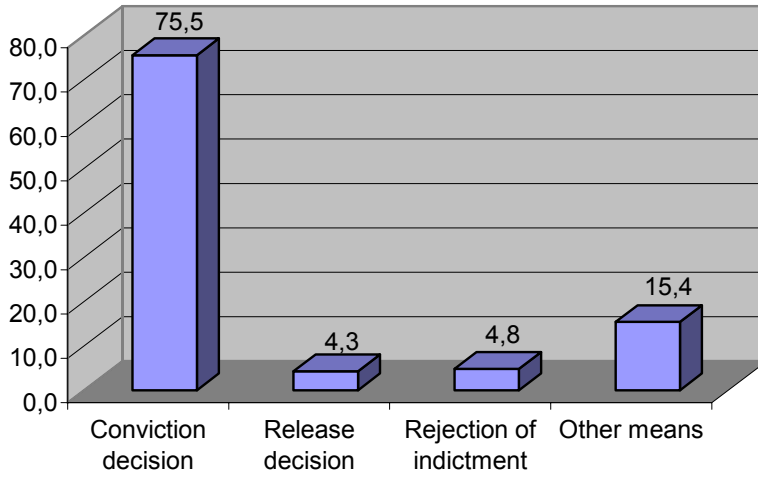


Chart 11: Type of indictment proceedings in District Courts by %

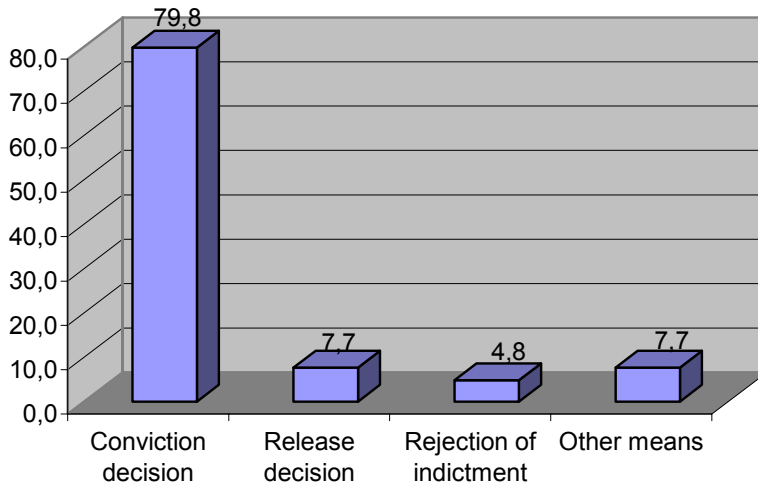

Chart 12: Duration of procedure against defendants in Municipal Courts by %

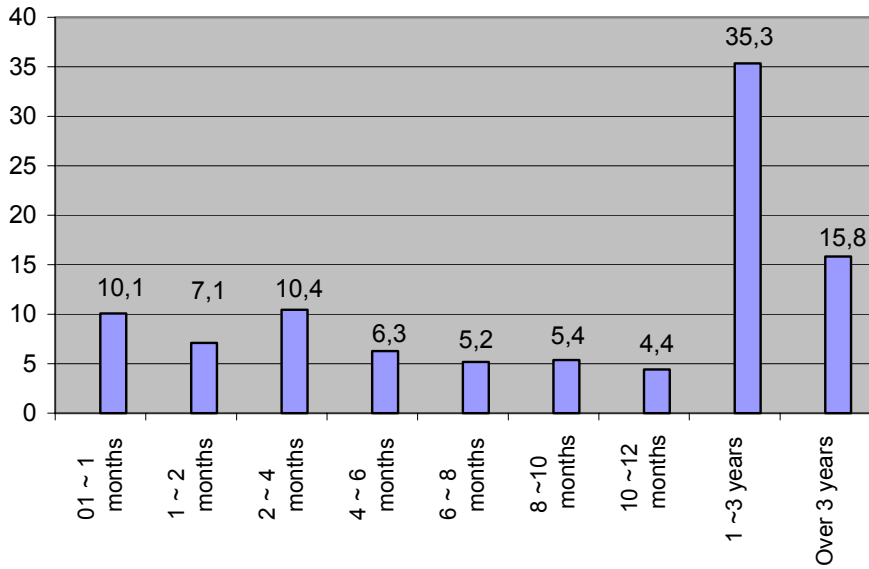


Chart 13: Duration of procedure against defendants in District Courts by %

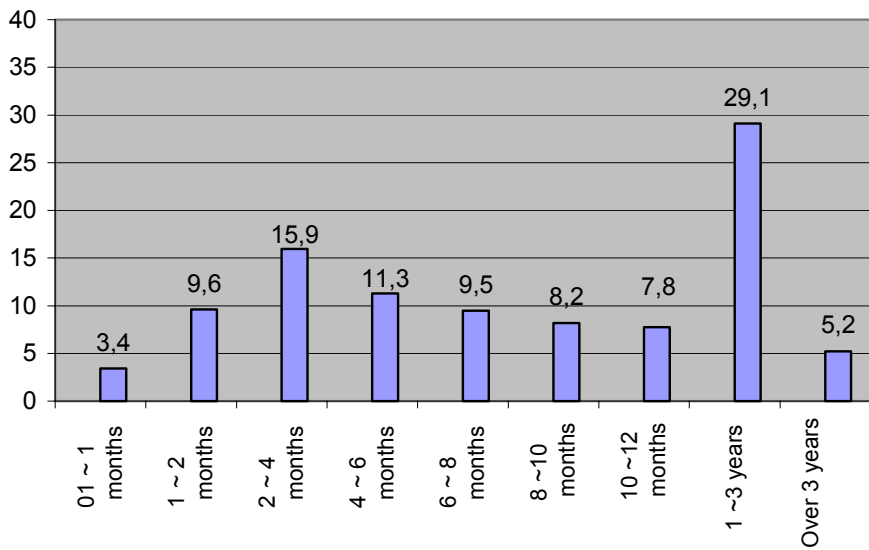

Chart 14: Punished persons by sex in Municipal Courts presented by %

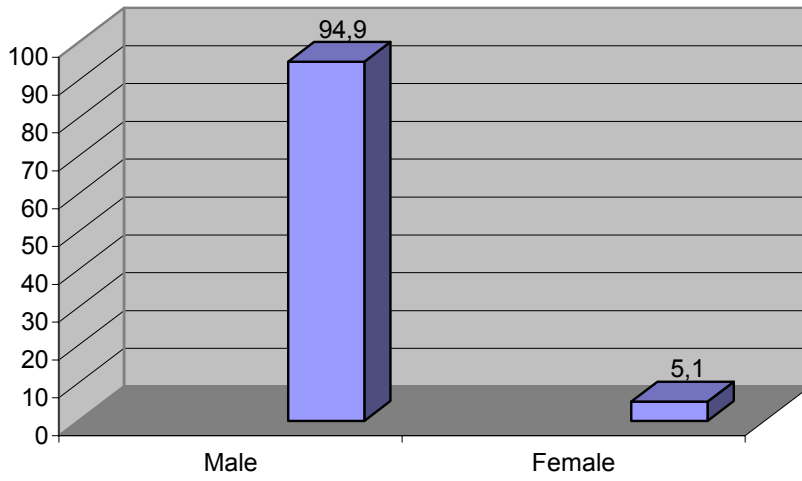


Chart 15: Punished persons by sex in District Courts presented by %

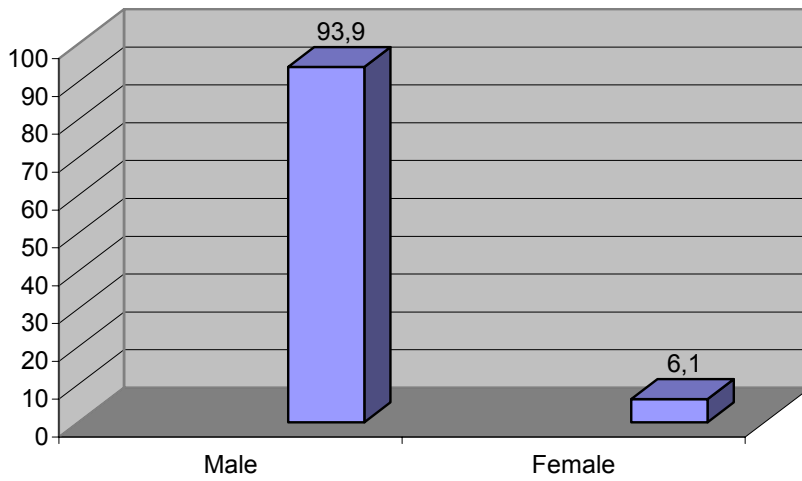

Chart 16: Punished persons by ethnicity in Municipal Courts presented by %

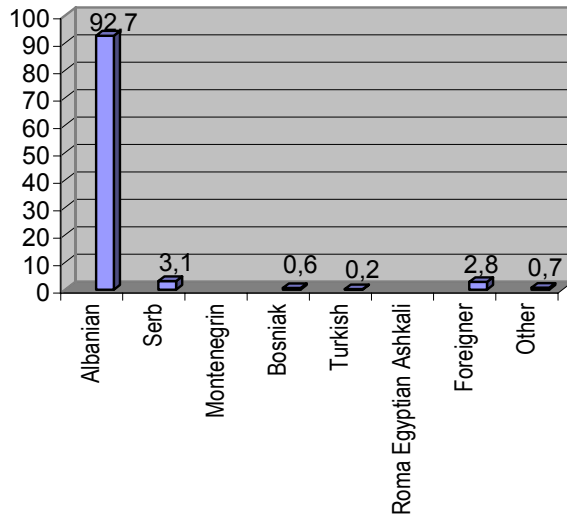


Chart 17: Punished persons by ethnicity in District Courts presented by %

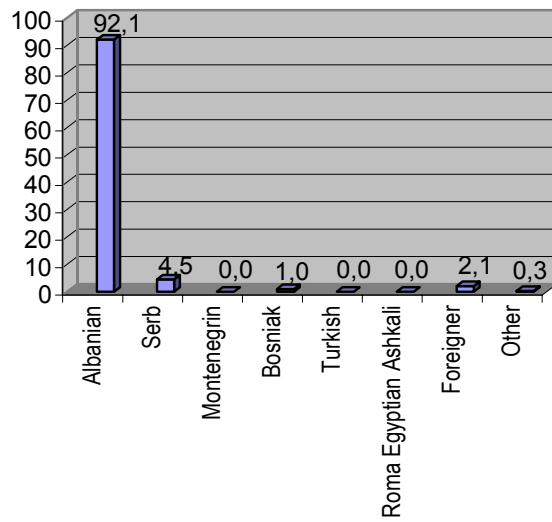

Chart 18: Number of juveniles punished in Municipal Courts according to 2003/2005

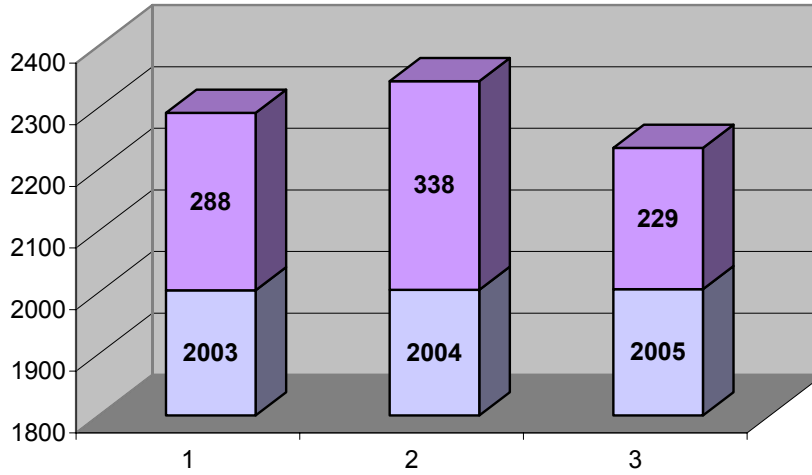


Chart 19: Number of juveniles punished in District Courts according to 2003/2005

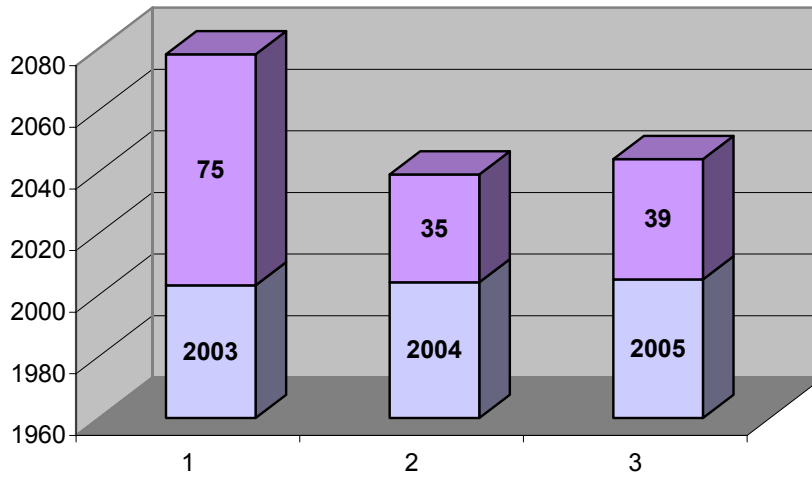

Chart 20: Juveniles accused in Municipal Courts by sex, ethnicity and motion for prosecution presented by %

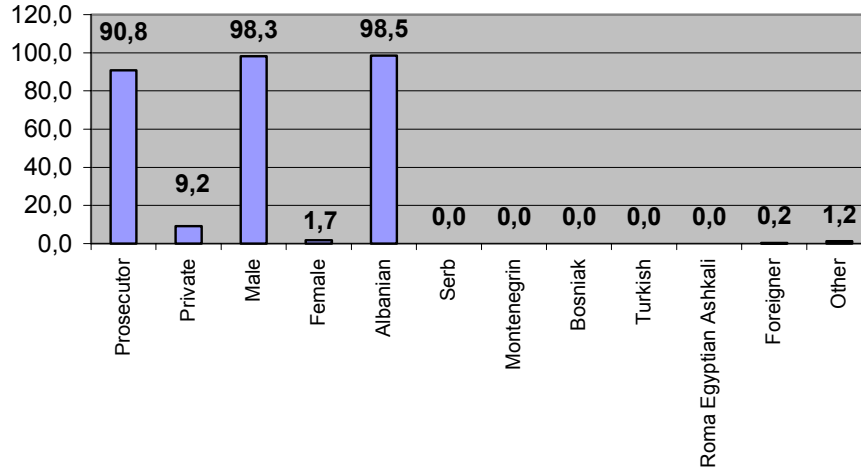


Chart 21: Juveniles accused in District Courts by sex, ethnicity and motion for prosecution presented by %

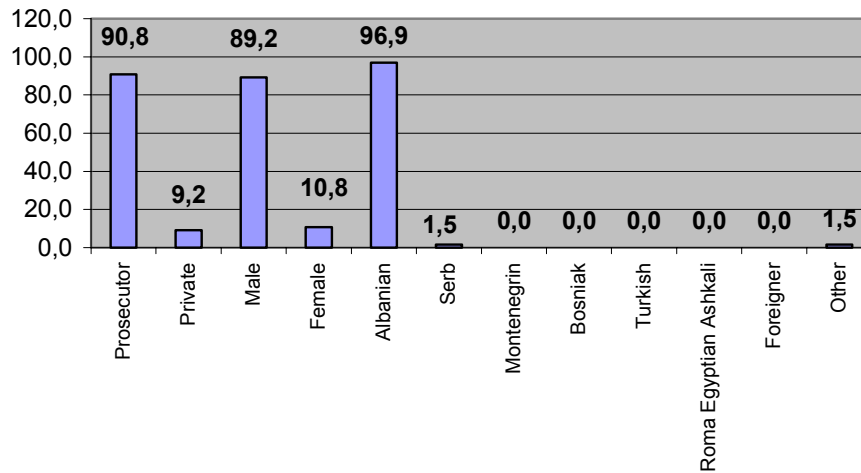

Chart 22: Type of indictment proceedings in Municipal Courts presented by %

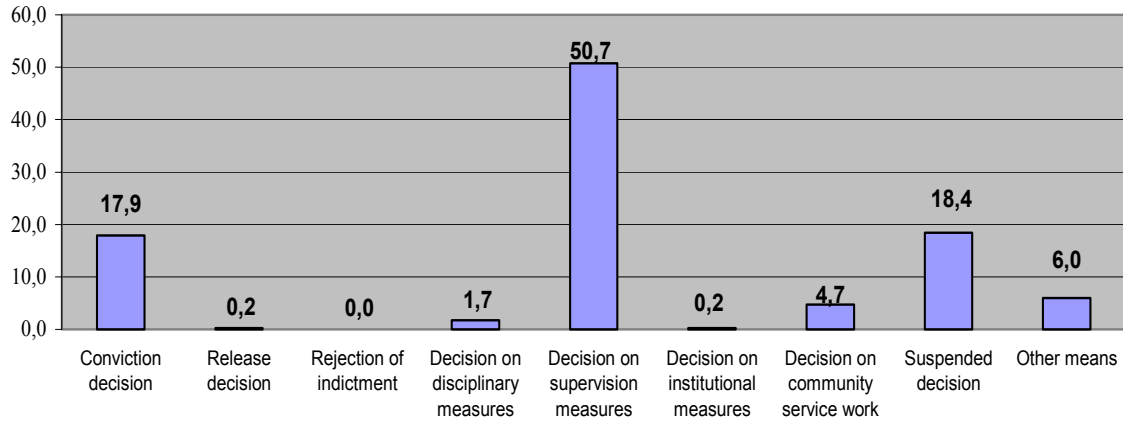


Chart 23: Type of indictment proceedings in District Courts presented by %

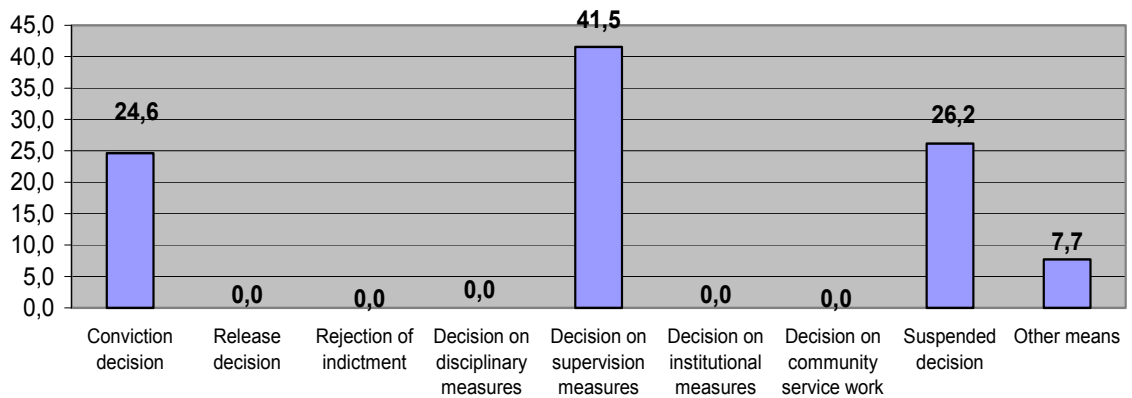

Chart 24: Juveniles punished in Municipal Courts by sex, ethnicity and motion for prosecution presented by %

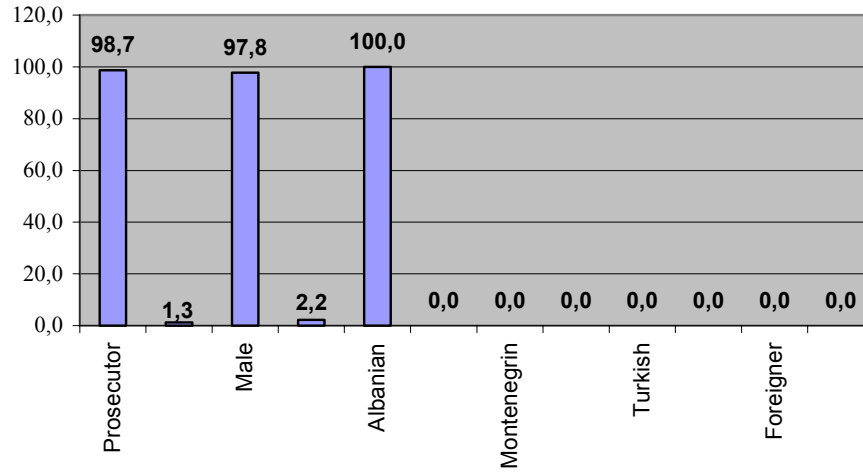


Chart 25: Juveniles punished in Municipal Courts by sex, ethnicity and motion for prosecution presented by %

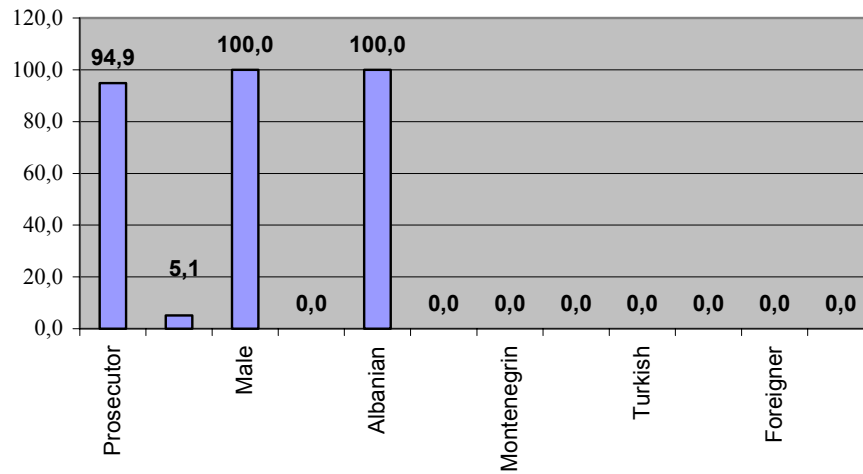

Chart 26: Types of punishments against juvenile defendants pronounced in Municipal Courts presented by %

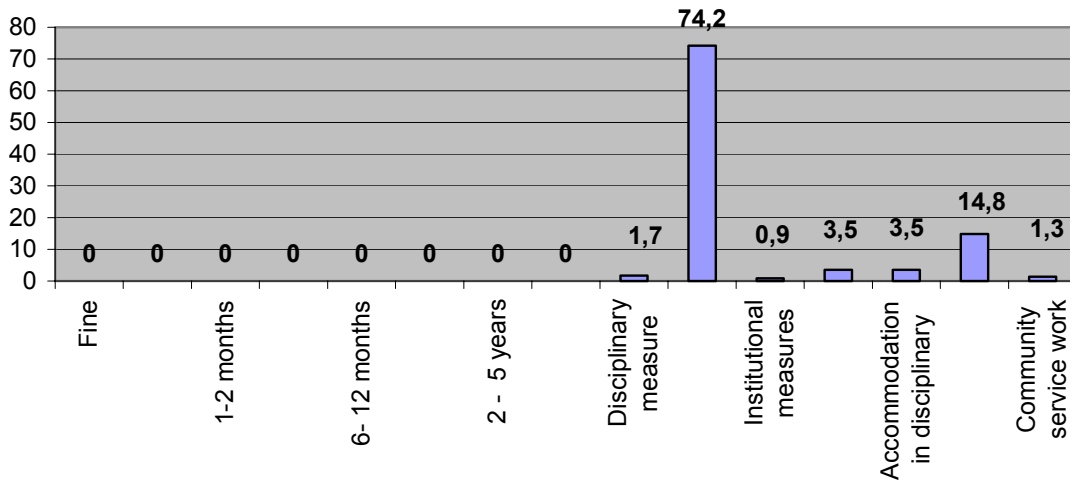


Chart 27: Types of punishments against juvenile defendants pronounced in Municipal Courts presented by %

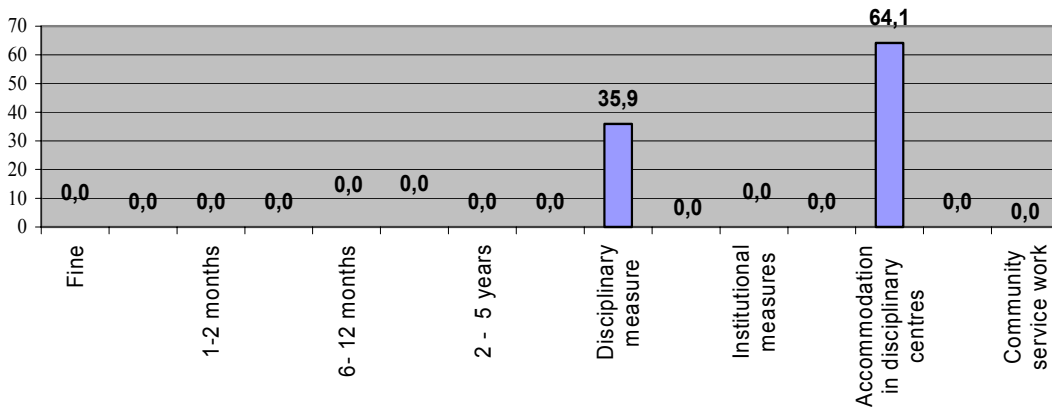

Chart 28: Juveniles punished in Municipal Courts of criminal offences by type of offence and number of perpetrators in commission of criminal offence presented by %

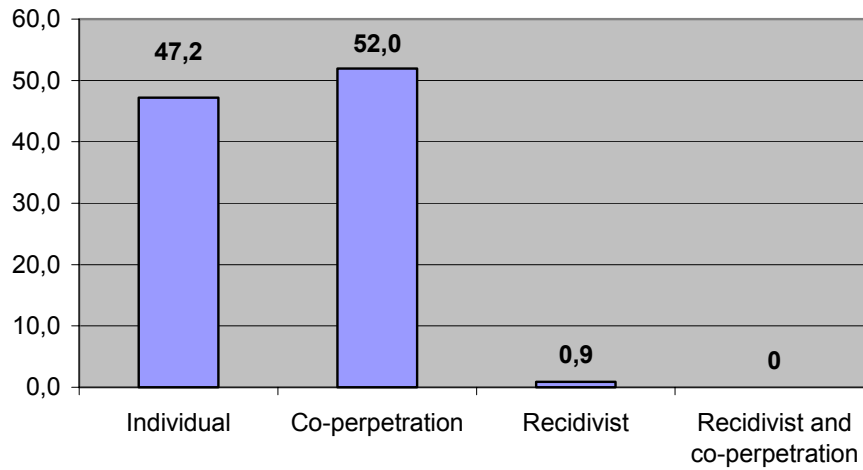


Chart 29: Juveniles punished in District Courts of criminal offences by type of offence and number of perpetrators in commission of criminal offence presented by %

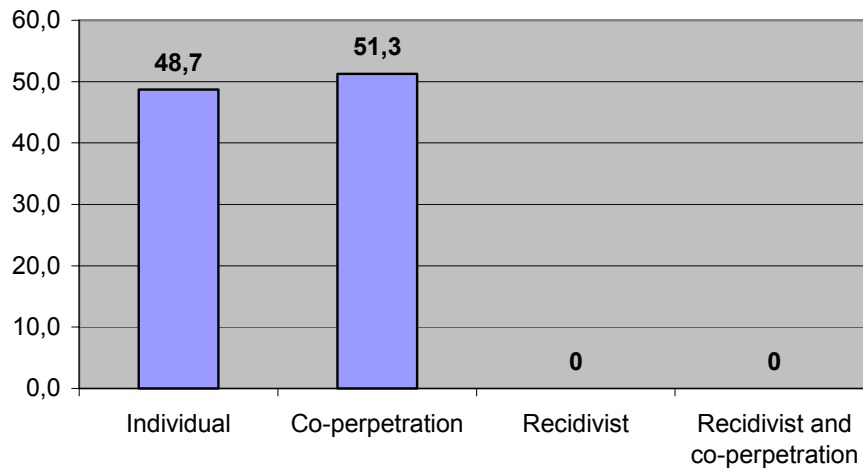

Chart 30: Persons punished of minor offences by years: 2003-2005

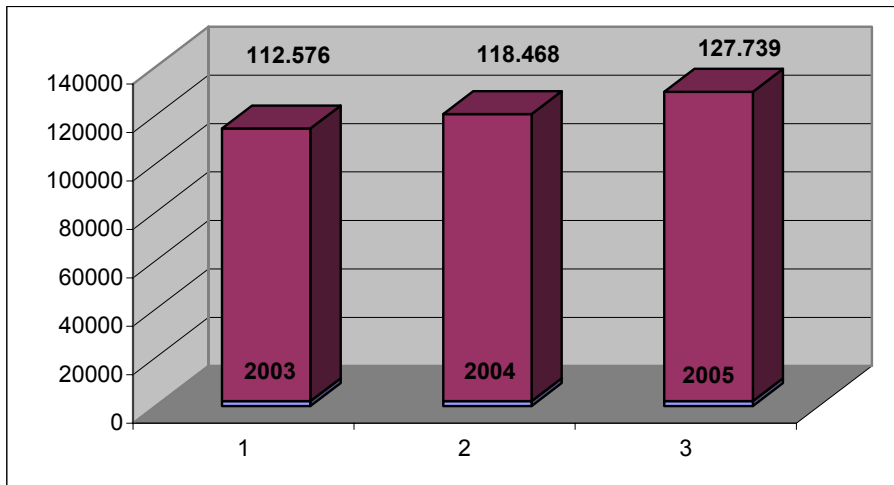

Chart 31: Persons punished of minor offences in Municipal Courts in 2005 presented by %

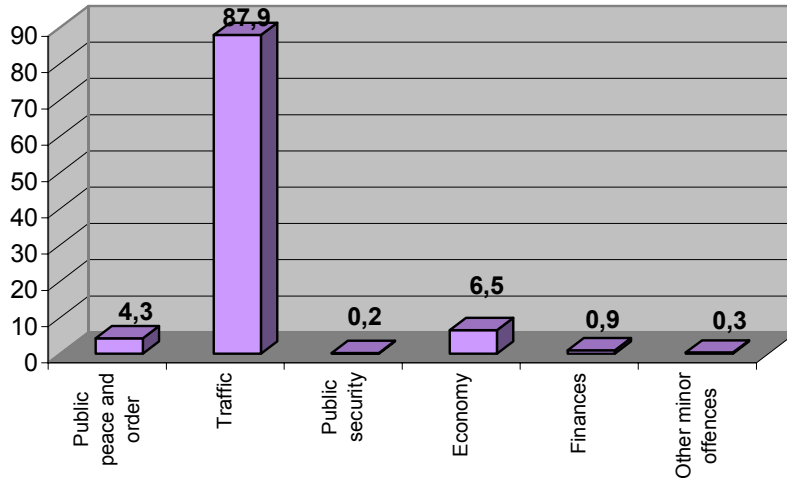

The legal status of persons punished of minor offences is as follows: 1 238 (0,2%) legal persons, 126.638 (99,1%) physical persons, 863 (0,7 %) juveniles. The following types of punishments have been pronounced; warnings against 3.384 (2,6%), educational measures against 442 (0,3%), fine 123.547 (96,7%), sentenced to imprisonment 341 (0,3%) and preventive measure without punishment against 25 persons.

Chart 32: Persons punished of minor offences by legal status presented by %

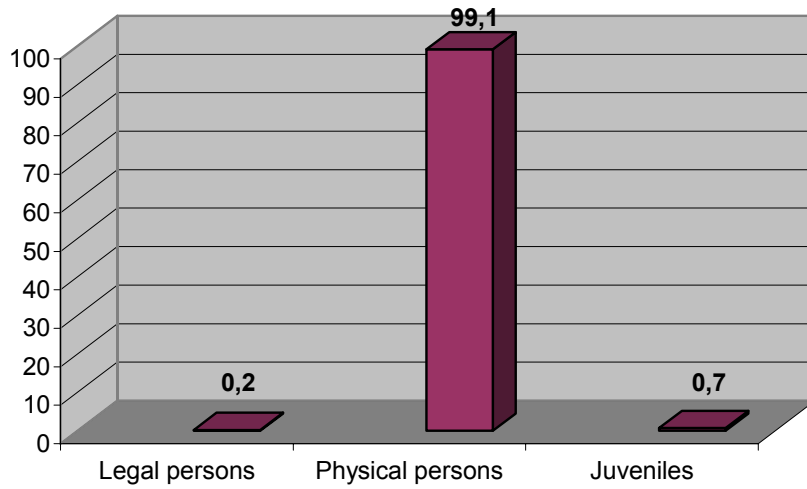
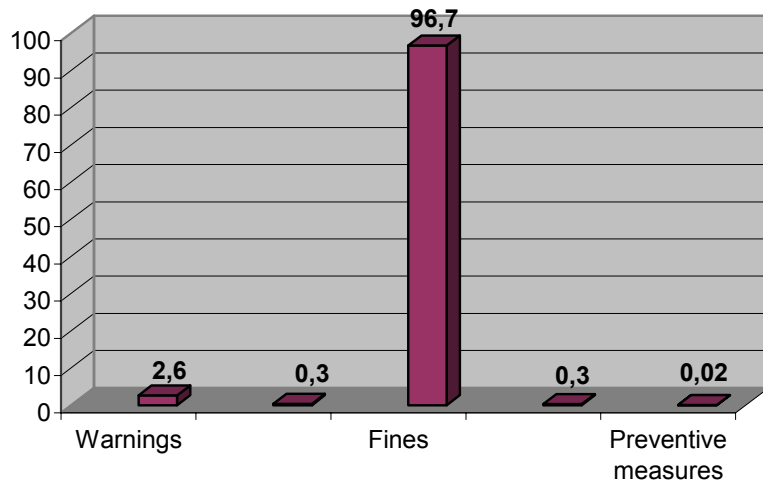


Chart 33: Persons punished of minor offences by type of punishment presented by %



Notice to users

Judicial System

According to the level of organization of courts, the judicial administration is exercised by:

- Municipal Courts,
- District Courts,
- Supreme Courts,
- Commercial District Courts,
- Municipal Minor Offences Courts,
- High Minor Offences Courts.

Courts are bodies of the state government.

Exercising the judicial administration, courts are eligible to decide on basic personal relations contests, the rights and obligations of citizens, they pronounce punishments and other measures against defendants committing criminal offences and other offences punishable by the applicable law. They also decide on the legality of various activities of state bodies, they resolve property and labour relations contests as well as decide on other relations as set forth by the law.

Observation Units

Observation units are the perpetrators committing criminal offences.

The term perpetrator means an adult or juvenile person committing a criminal offence either as an immediate perpetrator, co-perpetrator, instigator or aide.

Adult perpetrator is considered a person who at the period of the commission of the criminal offence was at full age of 18 years.

Juvenile perpetrator is considered a person who at the period of the commission of the criminal offence was at full age of 14 years, but who has not reached the age of 18 years.

Juvenile perpetrators committing criminal offences are divided into:

- a) Minor juveniles
- b) Grown-up juveniles

Minor juveniles are persons committing criminal offence belonging to the age group 14-16 years. Only educational measure can be pronounced against this category.

Grown-up juveniles are persons belonging to the age group 16 – 18 years. In principle, educational measures are pronounced against this category, yet in certain cases they can be sentenced to imprisonment for juveniles in accordance with the law.

Classification of crimes

Classification of crimes (criminal offences) by their type is always done referring to the applicable Criminal Law (Criminal Code).

Term of criminal offence ^a

Criminal offence is an unlawful act which is defined by law as a criminal offence, the characteristics of which are defined by law and for which a criminal sanction or a measure of mandatory treatment is prescribed by the law.

a. Term of criminal offence is taken by Article 6 of Kosovo Provisional Criminal Code of

Statistical Office of Kosovo (SOK) - a brief description

The Statistical Office as a professional office has been in operation since 1948, and has passed through all the historic phases of Kosovo. On August 2nd 1999 the Office restarted its work as an independent and professional institution of public administration of Kosovo. Kosovo Consolidated Budget and various donors for particular projects finance the Office.

A Statistical Regulation (Regulation 2001/14) came into force 2 July 2001. SOK is an executive agency attached to the Ministry of Public Services (MPS). A Master Plan (medium term development plan) for the statistical system in Kosovo has been produced.

Organization structure: Seven Regional Offices (Pristine, Peja, Gjakova, Prizren, Ferizaj, Gjilan and Mitrovica) and Head Quarters in Prishtina have at present a total of 137 employees, 90 at HQ and 47 at the Regional Offices. There is 1 Long Term Consultant from Statistics Sweden, financed by Sida and 1 Project Coordinator, Statistics Sweden Projects, SOK. The Office has a fully-fledged field organization for surveys with experienced enumerators and sufficient transport. Local and international expert group are working in the population census project.

The Office Mission is to fulfill the needs of users for objective statistical data and analyses in order to support government departments and provide proper information for decision-makers and other users in Kosovo.
