### **Production of coal in the fourth quarter of 2018**

In the fourth quarter of 2018, production of coal is 1 928.4 thousand tons.

### **Gross electricity production in PP & HPP in the fourth quarter of 2018**

In the fourth quarter of 2018, the gross amount of electricity produced in power plants is 1 362.1 GWh, while in hydro power plants it is about 54.1 GWh.

### **Import and export of electricity in the fourth quarter of 2018**

In the fourth quarter of 2018, Kosovo imported 347.6 GWh of electricity.

In this quarter (Q4 2018), Kosovo exported 88.6 GWh of electricity.

### **Final consumers in the fourth quarter of 2018**

In the fourth quarter of 2018, the amount of electricity consumed was 1 159.2 GWh of electricity. In relation to the same quarter last year (Q4 2017), the amount of electricity consumed increased by 6.0%.

### **Import and export of fuels in the fourth quarter of 2018**

## Methodological explanations and definitions

**<sup>1</sup>Electricity** - means the form of energy which is transported through metal conductors.

**Energy** – means any form of manufactured or obtained energy (electricity, heating or natural gas) for supply or sale purpose.

**Energy fuel** - fuels which release the energy during combustion are called energy fuels.

**Energy enterprise** - means electricity company which carries one or more of the following energy activities: production, transformation, transmission, distribution, supply, trading or disposal of electricity, heat or natural gas under a license issued by the Law on Energy Regulator or without a license if such license is not required.

**Production of coal** - represents the amount of coal that is extracted from the mines.

**Production of electricity** - represents the amount of electricity produced in power plants and hydropower plants.

**Power generation** - implies the generation of electricity, heat or any other form of energy.

**Gross energy production** - represents all the amount of electricity production in power plants or hydropower plants.

**Net energy production** - represents the amount of electricity to the brink.

**Imports of electricity** - represents the amount of electricity purchased outside the state.

**Exports of electricity** - represents the amount of energy sold outside the state.

**Exchanges of electricity** - represent the amount of electricity exchanged or produced in the country and abroad.

**Losses of electricity** - represent the amount of electricity that is lost in transmission and distribution.

**Consumer** - means the consumer to purchase wholesale or the end (final) consumer of energy.

**Privileged consumers (220-110kV)** - means any natural or legal person who is free to buy electricity from the supplier to the choice of his/her.

**Distribution** - means that transport of electricity, heat or natural gas through high voltage lines, medium, or medium-pressure pipelines or low, in order of a delivery to customers, but not including supplies.

**(2702) Lignite**- whether or not agglomerated, excluding jet.

**(2703) Peat-** (including its waste or litter), whether or not agglomerated.

**(2704) Coke** and semi coke of coal, Lignite or of peat. Whether or not agglomerated; retort carbon:

**(2705) Coal gas**, water gas, producer gas, weak gas and similar gases (EXTL. petroleum gases and other gaseous hydrocarbons)

**(2706) Tar distilled from coal**, from lignite or from peat, and other mineral pitch, whether or not dehydrated or partially distilled including tar rebuilt.

**(2707) Oils and other products** of the distillation of high temperature coal tar, similar products in which the weight of the aromatic constituents exceeds those of non aromatic.

**(2708) Turpentine and turpentine coke**, obtained from coal tar or from other mineral tars.

**(2709) Petroleum oils** and oils obtained from bituminous minerals, crude.

**(2710) Petroleum oils** and oils obtained from bituminous minerals, other than crude; preparations unspecified and not elsewhere, containing by weight 70% or more of petroleum oils or oils obtained from bituminous minerals. These oils being the basic constituents of the preparations.

**(2711) Petroleum gases** and other hydrocarbon diesel.

**(2712) Gelatin oil**, paraffin wax, microcrystalline petroleum wax, liquid wax, ozokerite, lignite wax, peat wax, other mineral waxes, and similar products obtained by synthesis or by other processes, whether or not colored.

**(2713) Coconut oil**, bitumen and other residues of oils obtained from bituminous minerals.

**(2714) Natural bitumen and asphalt**, bituminous or oil-shale and tar sand, asphalt and asphaltic rocks

**(2715) Bituminous mastic** backed and other bituminous mixtures based on natural asphalt, bitumen supernatural, oil bitumen or mineral tar.

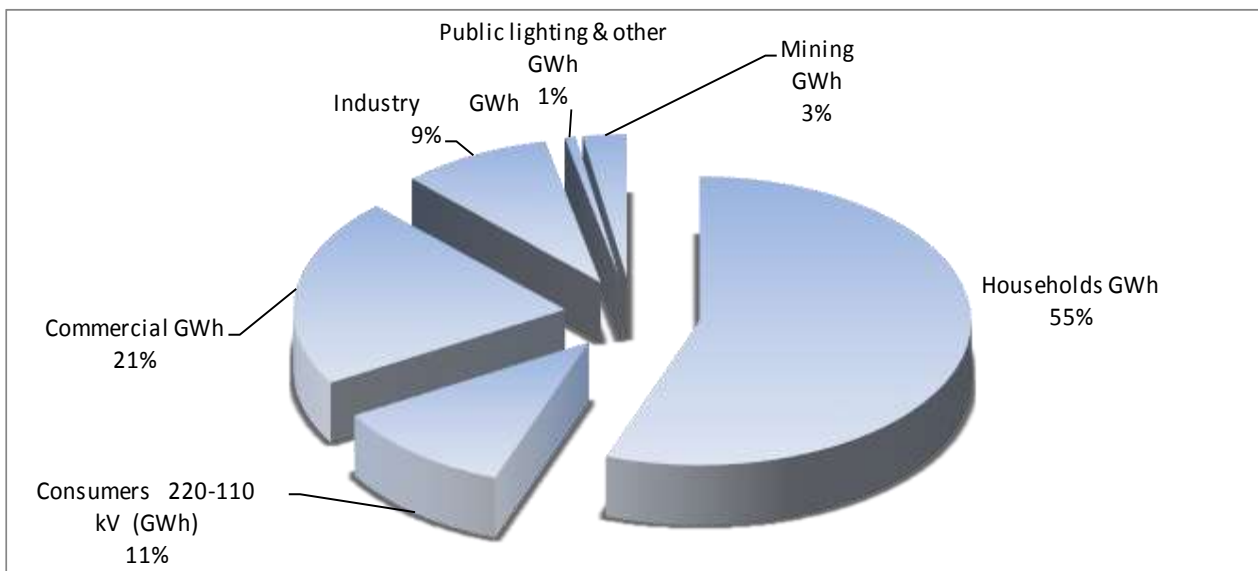

# Kosovo Agency of Statistics

## *short description*

**Kosovo Agency of Statistics** is a professional institution which deals with collection, processing and publication of official statistical data. As such acts since 1948 and has passed through several historical stages, structured according to state regulation of those times.

On 2 August 1999, the Agency has resumed his professional work (after nine years of interruption of all statistical series detrimental to the interest of Kosovo), as an independent institution under the Ministry of Public Administration. Since 12.12.2011 the Agency operates in the frames of the Prime Minister's Office. Office is funded by the Kosovo Consolidated Budget, but also by donors for specific projects and for technical professional support.

**Kosovo Agency of Statistics** acts according to the Law No. 04/L-036 which entered into force on 12.12.2011. Programme of Official Statistics 2013/2017 is in implementation for the development of statistical system in correlation with the European Union statistics (EUROSTAT).

**Kosovo Agency of Statistics** has this organizational structure: production departments; Department of Economic statistics, Department of National Accounts, Department of Agriculture and Environment statistics and Department of Social statistics. **Support Departments**; Department of Methodology and Information Technology, Department of Policy Planning, Coordination and Communication, Department of Census and survey and Department of Administration. **Within the Agency are also established Regional Offices**; Gjakove, Gjilan, Mitrovica, Peja, Prizren, Pristina and Ferizaj

In KAS are employed in total 155 workers, of whom 100 (68,0 %) at the headquarters of the Agency, while in the Regional Offices, 47 (32,0%). Agency's educational qualifying structure is as follows: 75,5% with university education, 12,3% with with non-tertiary education, and 12.3% with secondary education.

We have professional and technical cooperation with all Ministries of the Government of Kosovo, especially with the Ministry of Economy and Finance, Central Bank of Kosovo, with international institutions, EUROSTAT, International Monetary Fund, World Bank, Sweden's SIDA, DFID, UNFPA, UNDP, UNVEF, and with the statistical institutions of the countries in the region.

**Kosovo Agency of Statistics** almost completely covers the territory of Kosovo, based on the statistical structure of the enumeration areas as the basic unit and sole in the country from which it gets first hand information. All surveys conducted in the field use the extension of the samples in these enumeration areas but also a statistical methodology according to international recommendations. During the collection of statistical data and reports from reporting entities are involved professionals, technicians, administrators, servants of the country offices, field enumerators from regional offices, etc.

In 2011, the project of Population Census , Households and Dwellings was successfully implemented, and in 2014 was successfully carried out the Agriculture Census. The result obtained from these censuses will have an important role in the development policies.

**The mission of the Agency**; to meet the needs of users with qualitative statistical data, objective, in time and space so that users have reliable base to conduct regular analysis in the interest of planning and project development at the municipal and country level. To support government institutions, scientific institutes, research academies, businesses in order to provide proper information for decision-makers and other users in Kosovo.
